- For the Dongria Kondhs it is better to have to decide who they will no longer lend their vote to but first their names have to be cleared from the <u>Naxal</u> cases.
- To them, by virtue of yet to be fully exonerated names, they will not be ready to exercise their franchise rights without the due respect.
- Nothing short of this has gone to the national government as they are envisaging to present a notification establishing them innocent or even better to find all cases against them a closure.

# **Struggle for Justice**

- The controversy between Dongria Kondhs and the bauxite developers is not new and a continuous fight for justice has been going on for many years.
- They have been protesting, making rallies and are volunteering to sign petitions to their government to make them aware that they have rights over their portfolios.
